

2021 Safe Harbor Foundation Pontoon Raffle Contest Rules

The Prize

One (1) afternoon or evening pontoon ride for ten (10) people on Richmond Lake in South Dakota. The pontoon will be captained by Lee Keller and martinis will be mixed by Paul Weiss. A charcuterie board will be provided by Jesse Cantalope and additional beverages can be coordinated with Lee Keller. Must schedule two weeks in advance between July 5, 2021 and September 1, 2021. Winner and guests are responsible for their own transportation to and from the launching point for the pontoon.

Raffle Ticket Sales

You may purchase one (1) ticket for \$100. Multiple tickets can be purchased by a single individual. Tickets will only be sold online at safeharborsd.org/news-events/events-2/pontoon-with-a-purpose/ starting on June 1, 2021. Only fifty (50) tickets will be sold and ticket sales will automatically stop once that threshold is hit. Odds of winning are 1 (one) in 50 (fifty). All tickets purchases are final and non-refundable.

Any person 21 years of age or older is eligible to enter.
