The Prizes

Raffle Ticket Sales

You may purchase one (1) ticket for \$20 or six (6) tickets for \$100. Tickets will only be sold online at safeharborsd.org/purse starting on June 3, 2022. Once drawings begin, all tickets purchased by 11:00 am CST will be included in the drawing for that day. The Safe Harbor Foundation Board President's computer will be the official time keeping device for this raffle. Odds of winning depend on the number of eligible tickets sold. Non-winning tickets will rollover into any subsequent drawing(s). All tickets purchases are final and non-refundable.

Safe Harbor is not responsible for any problems or technical malfunction of any telephone network or lines, computer online sites, servers, or providers, computer equipment, software, failure of any other technical problems or traffic congestion on the internet or website.

Eligibility

Any person 18 years of age or older, persons under 18 years of age will need parental consent to purchase raffle tickets.
